



Average daily auto registrations, E-Way bill generation shows recovery signs



Daily vehicle registration continues to show uptick in June



Daily vehicle registrations rose \sim 22% week on week, averaging \sim 57,000 units i.e. \sim 72% of pre-Covid levels during the week (August 17-20) against \sim 59% levels seen in the preceding week


(Note – Andhra Pradesh, Madhya Pradesh and Telangana are non-Vahan states. They combined form ~15% of auto volumes and ~20% of tractor volumes)

E-Way bill generation for August (till 16) continued its momentum on a strong note reaching 2.3 crore. If we extrapolate this and compare it to the average bill generation in the months prior to Covid-19 (October 2019-February 2020) has reached ~80% levels of the average 5.5 crore bills. E-Way bill generation for of April, May, June and July hovered at 16%, 46%, 79% and 88% levels, respectively






