

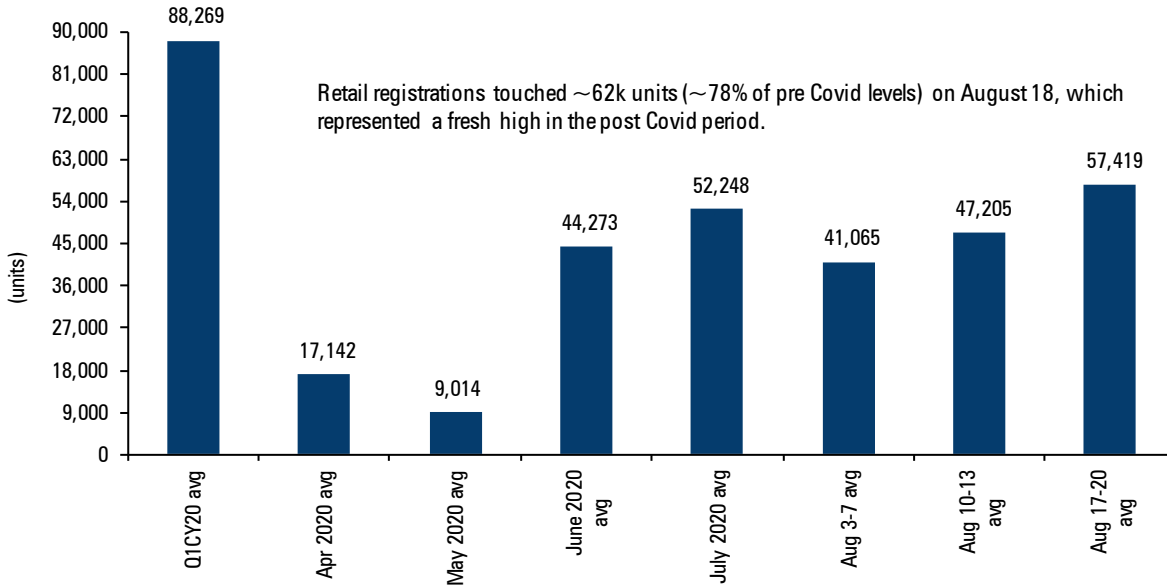

Average daily auto registrations, E-Way bill generation shows recovery signs

Daily vehicle registration continues to show uptick in June



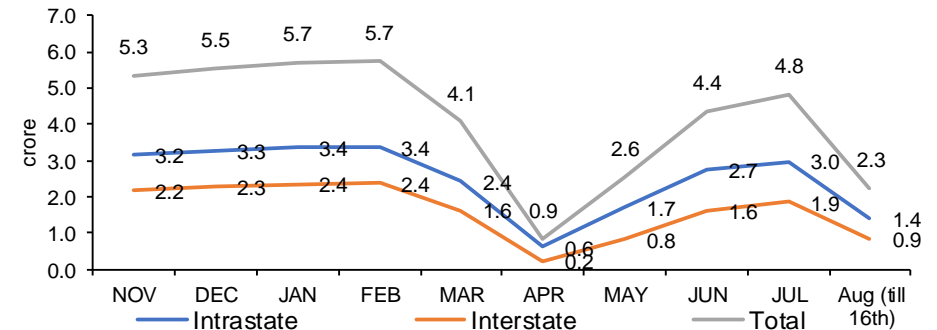
Retail registrations touched ~62k units (~78% of pre Covid levels) on August 18, which represented a fresh high in the post Covid period.

Daily vehicle registrations rose ~22% week on week, averaging ~57,000 units i.e. ~72% of pre-Covid levels during the week (August 17-20) against ~59% levels seen in the preceding week

(Note - Andhra Pradesh, Madhya Pradesh and Telangana are non-Vahan states. They combined form ~15% of auto volumes and ~20% of tractor volumes)

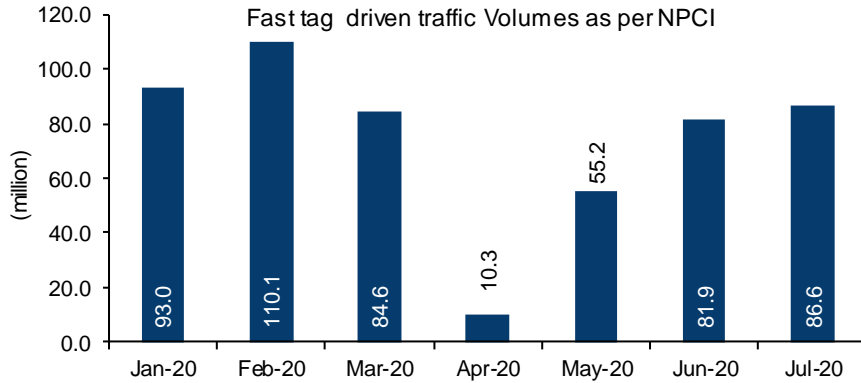
E-Way bill generation for August (till 16) continued its momentum on a strong note reaching 2.3 crore. If we extrapolate this and compare it to the average bill generation in the months prior to Covid-19 (October 2019-February 2020) has reached ~80% levels of the average 5.5 crore bills. E-Way bill generation for of April, May, June and July hovered at 16%, 46%, 79% and 88% levels, respectively

E-Way bill generation



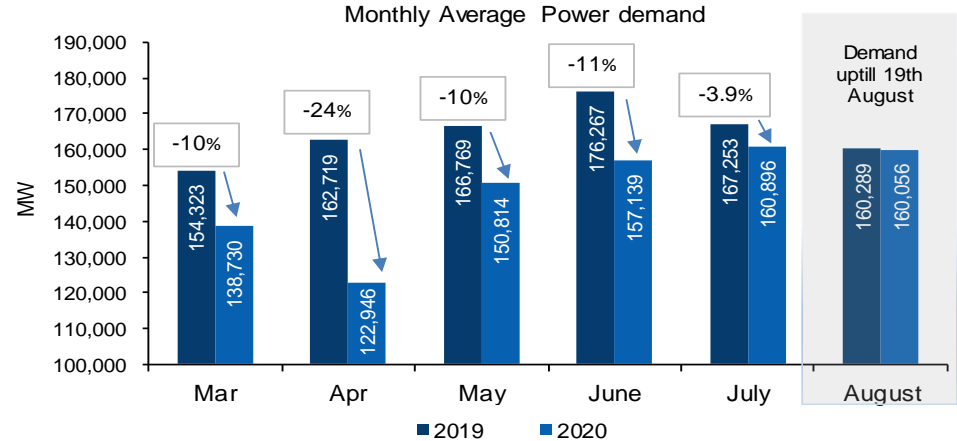
Power demand & FASTag data indicating gradual recovery

Fast tag driven traffic volumes



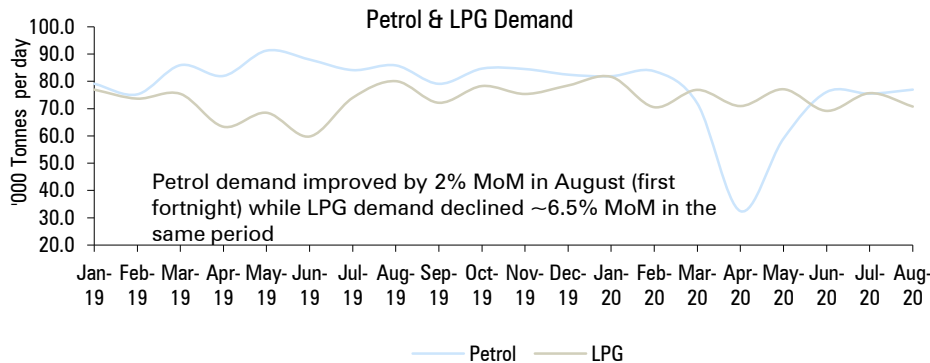
NPCI data reveals that monthly vehicle volumes at various toll plazas (86.6 million) have reached ~79% levels in July (vs. ~74% levels in June) of pre-Covid operations.

Monthly average peak power demand in 2019 & 2020

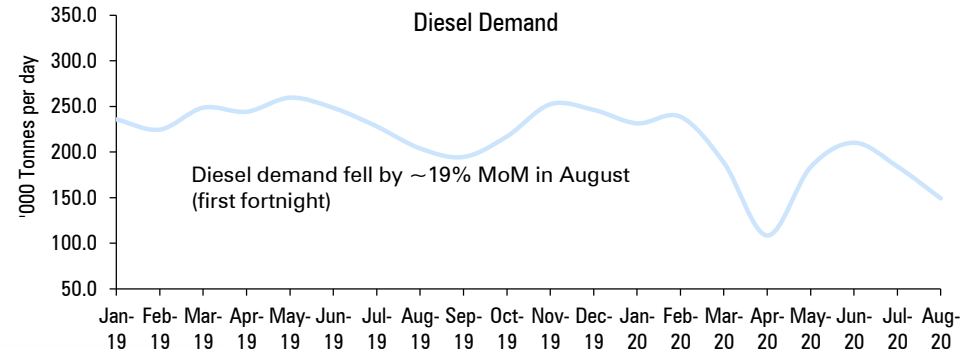


Average peak power demand has almost reached normal levels clocking at 160 GW until August 19 vs. 160.2 GW in the corresponding period in 2019
