



Daily Vahan registrations remain flat...



Daily vehicle registration trend



Daily Vahan registrations broadly remained flat week on week with current reading for August 2022 on MTD basis coming in at ~61,000 units i.e. ~76% of pre-Covid levels vs. ~67,500 units i.e. ~84% of pre-Covid levels till month. With strong order-book in the PV space across OEMs and improving supply chain dynamics, we expect vehicle registrations to improve and average at ~80% of pre-Covid levels for August 2022.


(Note – Starting June 2022 Andhra Pradesh has joined Vahan. Therefore, Vahan database now captures ~92% of auto retails across the country. Only Madhya Pradesh, Telangana and Lakshadweep remain as non Vahan states)


E-Way bill generation for July ended on a strong note, reaching 7.6 crore. If we compare this to the average bill generation in the months prior to Covid-19 (October 2019-February 2020), it has reached ~137% levels of the average 5.5 crore bills. E-Way bill generation for May, June, July, August, September, October, November, December, January, February, March, April, May and June hovered at 73%, 100%, 117%, 120%, 123%, 134%, 111%, 130%, 125%, 125%, 142%, 137%, 133% and 135%, respectively.



Average peak power remains flat YoY...











Average peak power demand for August (1-25) de-grew 0.55% to 183.8 GW vs. 184.6 GW in the same period last year. Peak power demand during the period was registered on August 19 at 192.7 GW.

Petrol & LPG demand





Diesel demand



IIP trend continues to impress...







Gross GST revenue collected in the July came in at ₹ 148995 crore. Revenues for July 2022 were 28% higher than GST revenues in the same month last year. Of total GST collection, CGST amounted to ₹ 25751 crore while SGST was at ₹ 32807 crore, IGST at ₹ 79518 crore (including ₹ 41420 crore collected on import of goods) and cess at ₹ 10920 crore (including ₹ 995 crore collected on import of goods).

The country's index of industrial production (IIP) grew 12.4% to 137.9 in June. The growth in IIP data during June was led by all sectors. The mining sector rose 7.5% YoY to 113.4 in June. The manufacturing sector witnessed growth of 12.5% to 136.3 while the electricity sector climbed 16.4% to 196.9.
