4. If you have requested to change your Default account, till such request is satisfactorily processed, the payout amount due to you, will be credited to your existing default account as appearing in the payee records.
5. ICICI Bank account, if already linked to your Trading/Investment account, will automatically become your default account.
6. If your default account is non functional/closed/inactive at any stage, ensure to inform ICICI Securities Ltd of the same on an immediate basis and apply for change of default account.
